HOLIDAY CLOSING OF THE BANKRUPTCY COURT ON JANUARY 2, 2015

In addition to the regularly scheduled closure on the Federal Holiday of January 1, 2015, all Divisions of the United States Bankruptcy Court, Middle District of Florida, will also be closed for regular business on Friday, January 2, 2015.

Rule 9006(a), Federal Rules of Bankruptcy Procedure, provides in part:

Rule 9006. Computing and Extending Time; Time for Motion Papers

(a) Computing Time. The following rules apply in computing any time period specified in these rules, in the Federal Rules of Civil Procedure, in any local rule or court order, or in any statute that does not specify a method of computing time

(1) Period stated in days or a longer unit

(c) include the last day of the period, but if the last day is a Saturday, Sunday, or a legal holiday, the period continues to run until the end of the next day that is not a Saturday, Sunday, or legal holiday... (Emphasis supplied).

IT IS ORDERED that because of the closing of the Divisions of the United States Bankruptcy Courts for the Middle District of Florida on January 2, 2015, time periods for all cases in the Divisions of the United States Bankruptcy Court for the Middle District of Florida are extended in accordance with Rule 9006(a), Fed.
