**ADMINISTRATIVE ORDER REGARDING COURT'S
NON-INTEREST BEARING CHECKING ACCOUNT AT BANK OF AMERICA**

The Court previously established local procedures to ensure uniformity in the deposit and investment of funds in the Court's Registry. Administrative Order FLMB-2015-10 governs the receipt, deposit and investment of registry funds. The Court finds that a non-interest bearing checking account at Bank of America was opened many years ago by the court for deposit of writ of garnishment funds. Since writ of garnishment funds are no longer required to be paid to the Court, there is no longer a need for the checking account. According, it is

ORDERED

1. The Clerk shall transfer funds currently on deposit with Bank of America, specifically identified in Exhibit A, to the Court's Treasury Registry non-interest bearing account.
2. An account for each case listed on Exhibit A shall be established in the name of the case and maintained by this Court in the Court's Treasury Registry account.
3. The Clerk shall close the checking account at Bank of America.
