ORDER AUTHORIZING BANKRUPTCY JUDGES TO MAKE LOCAL RULES  
OF BANKRUPTCY PRACTICE AND PROCEDURE FOR THE  
MIDDLE DISTRICT OF FLORIDA

Rule 9029 of the Federal Rules of Bankruptcy Procedure is entitled Local Bankruptcy Rules and provides, in pertinent part, that "[a] district court may authorize the bankruptcy judges of the district, subject to any limitation or condition it may prescribe and the requirements of 83 Fed.R.Civ.P., to make rules of practice and procedure which are not inconsistent with these rules and which do not prohibit or limit the use of the Official Forms." At the request of the Chief Judge of the United States Bankruptcy Court for the Middle District of Florida, the Judges of the United States District Court for the Middle District of Florida have considered this rule and have determined that it is appropriate to so authorize the Bankruptcy Judges.

It is therefore


ORDERED, ADJUDGED AND DECREED that the active Bankruptcy Judges of the Middle District of Florida are hereby authorized, subject to the requirements of 83 Fed.R.Civ.P., to make local rules of bankruptcy practice and procedure which are not inconsistent with the Federal Rules of Bankruptcy Procedure and which do not prohibit or limit the use of the official forms. It is further

ordered that if a proposed rule will impact on district court practices or will be inconsistent with district court local rules, Bankruptcy Judges will discuss the proposed rule with the District Judges of this Court prior to publication of the proposed rule.


